Dear Applicant:

The Department has completed its review of your project completion notice and has finalized the certification of Provisional Permit 76M 96918-00. Enclosed you will find a general abstract of your provisional water right.

In the Project Completion Notice that you submitted, you estimated 10.27 acres of lawn and garden were being irrigated in the King Ranch subdivision (the Department measured 8.55 total acres). Please note that this Permit is only authorized for irrigation of 3.21 acres of lawn and garden and using 9.00 AF/yr towards this purpose. The original application filed for this water right estimated irrigation requirements based on a plan for the majority of irrigation water to be supplied by the golf course irrigation system (Statement of Claim 76M 149107-00). If this is not the primary system of delivery, and the two wells associated with this Permit are irrigating more than 3.21 acres or using more than 9 AF/yr for this purpose, you are in violation of your Permit, and must either:

- 1) Transition to supplying any irrigated acreage and volume in excess of these amounts with the golf course system, as originally proposed
- 2) Apply for a new water right to cover the excess water use

Additionally, this water right requires that you report annual water usage to the DNRC. The last measurements received by the Department were from 2016. Please resume reporting.

THE REGIONAL MANAGER MAY ALSO REQUEST MEASUREMENT RECORDS AT OTHER TIMES DURING THE YEAR. FAILURE TO SUBMIT REPORTS MAY BE CAUSE FOR REVOCATION OR MODIFICATION OF A PERMIT OR CHANGE. THE RECORDS MUST BE SENT TO THE WATER RESOURCES REGIONAL OFFICE AT THE ADDRESS LISTED BELOW.
